PARISH COUNCIL

In December, Shillington Parish Council had two meetings. At the first, we heard about a proposal by the CBC Footpath Officer that might resolve the obstruction of Footpath 20 in the fields behind Woodmer Close. Discussions with the relevant landowners will continue.

A week later, councillors met to discuss the budget for the next financial year (2024-5). The Parish Council had dipped into its reserves to keep the precept unchanged in recent years. With the cost of providing many of services rising steeply, councillors agreed that the precept would need to be increased this time to ensure that the reserves are kept within the recommended level of 6 to 9 months of annual expenditure. Unfortunately, this will lead to a small increase in Council Tax. For contracts such as grass cutting that expire in April 2025, the council will explore if savings could be made by co-operating with other local councils and making economies. In the case of grass cutting, this might include changes to the areas that are mowed or to the frequency.

Some councillors were stuck in traffic and unable to attend the January meeting, held on a day that fierce winds caused many trees and branches to fall and block roads. Those who did heard that the people of Pegsdon were getting close to raising the money required for a debrillator. With the dark evenings at this time of year, the Parish Council tries to ensure that faulty street lights are fixed or replaced as soon as possible. By the time you read this, 81 of the 89 owned by the parish council will have been upgraded from the older sodium lanterns to more reliable and cheaper to run LEDs.

Following consultation between the Chair and the Police and Crime Commissioner regarding the possibility of installing a speed camera at Marquis Hill, we were told that more data would be needed to justify it. Traffic monitoring boxes were installed there and in High Road in December. Since the Council last met, we have heard that they have confirmed that speeding is indeed a significant problem and strengthened our case that more should be done to tackle it. The Police Traffic management unit have shared details with their enforcement teams and Central Bedfordshire Highways and we shall continue to keep this issue alive. A speed watch session took place on 15 January after poor weather ruled out an earlier one. Approved locations where the team can operate now include more sites in High Road, Bury Road, Hanscombe End Road and Upton End Road.

The chair, clerk and ward member attended a priority setting meeting with Bedfordshire police community teams and representatives from other local councils recently. Given that the county receives 'rural' funding from central government and despite having to deal with many 'urban' issues, the police claim that they are doing the best they can with limited resources and backed this up with the example of some of their officers who have filed more intelligence reports than whole teams in urban forces. Many of those at the meeting called for more "bobbies on the beat".

Our area (Flitwick & Ampthill) has just one PC (Sam Hewson) and one PCSO (Sarah Cane) to cover a large area and emergency calls may take them elsewhere. Given the issues the police face, intelligence and data-driven responses are key, which is why all crimes no matter how small should be reported to them on 101. They use this data to target responses and make funding and manpower requests. The meeting agreed that the police should focus on knife crime and youth violence for the next 3 months. Whilst Shillington has been lucky to avoid these is the most part, the intelligence of "county lines" drug gangs using rural communities and the related violence is an issue that is very much on our doorstep and shouldn't be seen as only a London or Luton problem.

NATURE NEEDS NIMBYS

Back in the day, I used to ask if you could possibly write to our (ex) MP Nadine Dorries about various issues. During the year when she kind of resigned, and then actually did resign, I almost gave up communicating with her as it seemed a waste of time.



However, we now have a new MP, Alistair Strathern, who is keen to engage with his constituents. Last December he held a surgery in Meppershall so I went and did a spot of engaging. I went to express my concerns about Keir Starmer being "keen to make it harder for 'Nimbys' to block housing development". I

pointed out to Mr Strathern that government and developers label people like myself, who are deeply concerned about the destruction of the countryside (building on greenfield sites) and environmental breakdown, as 'Nimbys'. This is an injustice. He agreed; sort of.

I mentioned that the way developers treat each new development in isolation from others is unacceptable; there is no looking at the whole picture. I said that around here displaced wildlife has hardly anywhere to move to that isn't threatened with development – and displacing wildlife isn't "protecting and enhancing" it.



I watched Question Time on the 11th January and the word 'Nimby' was mentioned a couple of times. It was very worrying listening to the panellist's response to the question: "Which party can I trust to meaningfully alleviate the housing crisis?". Anard Menon (Director of UK in a Changing Europe) said that "there's a need to find a way of going round planning; it's (about) ignoring local opposition. Greenbelt is an excuse for inaction. Building houses is a pathway to growth; it's good for the national economy and local protesters shouldn't be allowed to get in the way of that".



Another panellist, Lisa Nandy MP (Labour), basically agreed with him but was understandably, as there's an election looming on the horizon, more reticent and placatory. She said that there is no solution to the housing crisis, or to the growth crisis, without getting more homes built – Labour is therefore committed

to building 1,500,000 houses. There was no mention of the unacceptable number of second or empty homes in the UK, the use of brownfield sites or of social housing being lost to the Right to Buy scheme and not being replaced. And, with regard to Question Time, nobody asked the allimportant question: "Where will we get our food and water from when they build hundreds of thousands of mainly executive houses on our best agricultural land and in water-stressed areas?". With regard to housing, it was 'build, build, build' and to hell with anyone who says "but what about nature, soils to grow food and clean air and water?". Welcome to democracy.

There are those in power who, through legislation, are ensuring that we can't rock their economic growth at all costs boat - they want to keep on making loads of money building wrong houses in wrong places. Evil prospers

So I am sitting comfortably in a cinema with grandchildren, ready for a good snooze, watching a film called "Aquaman". I mean it took forever just to see the trailers and advertisements that apparently had been specially chosen to suit me before the real film came on. Lovely I thought, no nasty sounds or smells of crisps, no one talking loud into mobile phones.

Then before I had got some good shuteye the music is quite loud; it sounded exciting; I thought can I pick out the various instruments playing? Not much dialogue it seems – so I opened one eye.. Strange creatures appear on the screen. Lots of them. Some strange humans too. Lots of action and fast movements. It seems like serious stuff. Fighting and daredevil actions. I open the other eye. I can't believe I am still awake... This is not the plan... Now I am caught up

in whatever is going on. Looks like some kind of struggle to stay alive. There is talk of a sacrifice. Looks like a family fight. It seems like a Bible story. REPORT FROM COUNCILLOR BLAKE STEPHENSON - January 2024 -

Greenwoods – After such a long silence I followed up with the planning department. Central Beds has asked that the application be withdrawn. If this doesn't happen, it will be determined. I'm sure like me, many of you will be pleased that there is now some light at the end of this long tunnel.



Balancing budgets – Central Beds must agree a balanced budget, which it has done successfully over the past 14 years. But since political leadership changed last May, there has been huge over-spend and, to balance the books, Independent Councillors will propose; a 4.99% council tax increase, a charge for garden waste collection (likely £55 per household), spending £16.9m of reserves, and £22.8m of "efficiencies".

But ... bus grants have been saved – We don't all use the busses, but I know that those who do, have been understandably anxious about the proposal to axe the grants that pay for the Number 79. So over Christmas I organised a meeting with the bus operator, Grant Palmer, to understand the implications across the county. 37 routes in Central Beds are subsidised, so the impact would be widespread. I took the fight to the Council chamber with colleagues, and I'm pleased that the proposals have been shelved ... for now at least!

Highways – I reported last time that I had a motion at Full Council, which if successful, would require consultation and regular reporting by the administration on highways works. This is the start of my plan for more transparency, governance, and accountability for highways prioritisation. This *should* start to improve the influence we have over projects in our villages. And with such widespread support from across the political spectrum, there is certainly hope for better outcomes. But time will tell!

Community policing – Beds Police hosted a community priority setting meeting in January. The types of crimes reported from Mid Bedfordshire villages are remarkably similar; anti-social behaviour, drug activity, and speeding. Drugs and knives are on the rise in nearby towns too, and following discussions with our neighbouring villages and towns, community policing teams should now be focusing their work on these. Priority setting relies on intelligence from reported crimes, and the reports via 101 or <u>www.beds.police.uk</u> are very valuable, so please keep reporting crime, however low level you think it might be. Our watch scheme volunteers work hard keeping us safe too, and I thank you all.

PEGSDON



At time of writing, it's January, month of new beginnings, snowdrops and cold, cold winter. In keeping with new beginnings, welcome to our Pegsdon page, which I hope will be a regular entry in the Parish News. Let me catch you up on our goings on...

We've been fundraising for a defibrillator for quite some time and are now within inches of our target (https://www.aeddonate.org.uk/projects/23-095/). We've held coffee mornings, cakes sales, a raffle and a quiz, and with help from the Parish Council and our brilliant team at The View (prev. The Live and Let Live) success is finally in sight. The defibrillator will be installed at The View and several residents trained in its use, though this isn't essential as community defibrillators have visual and verbal prompts to aid the user. The defibrillator will be registered with The Circuit. Sudden cardiac arrests can happen to anyone at anytime and if treatment is given in the first few minutes chances of survival are hugely improved. With Pegsdon Hills on our doorstep and being at risk of a delayed 999 response in our location we're taking positive action. Sending a big thank you to everyone involved in the fundraising and everyone who donated, and especially Lainey and her team at The View for all their help and generosity.



TREE PLANTING PROJECT ON UPTON END ROAD – AN UPDATE

It is approaching 2 years since we originally planted the "wood" on the 27 acres of fields on Upton End Road, and we do occasionally get asked how it is faring, so we thought it was worth putting together this little update.

As a recap, it took 4 years from buying the land (in July 2018) to actually getting trees in the ground but we did eventually see the delivery of 10,000 juvenile trees and shrubs in February 2022. They were all UK native species, with a weighting towards fruit and nut varieties to provide a source of food for the wildlife (Wild Cherry, Oak, Rowan, Sweet Chestnut etc).



Planting took place on an exceptionally wet February fortnight. The recent rainfall we have had is a little reminiscent.....It was hard, muddy work for the planting team but at least the saturated ground would give the trees a good start (we hoped). However, we hadn't reckoned on an exceptionally dry spring, which was followed by record summer temperatures, also dry.

The juvenile trees were little more than 12 inch 'twigs' when they went in so, through 2022, it was difficult to see whether they were alive or not - we had to just let nature take its course. The first real test was spring 2023.



Our initial view was bleak. We concentrated our first check on the main central field and this looked awful. We estimated that barely 10% of the trees had survived, with a slightly better hit rate for the shrubs. Amongst the survivors, Oaks at least seemed to have fared the best. Clearly, given the planting density no one would expect all 10,000 to survive; the Forestry Commission suggests the general survival rate should be closer to 50%.

However, with so many natural variables at play there will be outliers to this average. Subsequent checks in the other two fields were more encouraging, and here the survival rate was a bit better, and we estimate we might have over 2,000 growing trees. Some are really thriving, for example there are a number of wild cherry trees already visible above the top of their protectors.

The main aim of this project for us was to "rewild" the land and that is definitely happening. There is ample evidence of birds and animal life. We saw hares running around in Spring 23 and there are clear deer trails. We even found some vole/field mouse nests made inside the tree protector tubes. So whilst the tree count could have been better, we're pleased we did it; this is after all



a 100 year project, and there's little doubt that those fields will eventually become woods.

We are currently considering replanting the larger field, but at a lower density and with a view of getting them in the ground before the start of next winter. Last week our good friend in the village, Dave Clarke, told us he had some potted trees and on a sunny Saturday morning we spent a couple of hours planting these (so we added around 50-60 more). They, at least, looked better specimens than we recall of our original batch and as they are in the ground earlier, stand a better chance to establish their root system and survive.



So if anyone else has some UK native trees they have grown in pots but which they no longer want, please let us know. We have grown some from scratch too, but it's a constant battle to beat the squirrels to the walnuts and acorns, they even dig them out of our pots!

We are now about to place an order on a successful contractor so these can commence shortly.

As with any building of this age there is a growing list of projects and we hope in time to install solar panels as grants become more readily available. We will be updating the CCTV shortly with more cameras and wifi. We're also working on a new website, to enable online bookings and payments, hopefully launching in the spring.

Since 2020, the richest 1% of people have accumulated \$26 trillion in new wealth - nearly twice as much as the rest of us. So claims Oxfam who have just published a report, *Inequality Inc*, that shows that two thirds of global wealth generated since Covid struck has gone to the fortunate few who already have a lot. In this country between 2010 and 2021, overall wealth rose by £4 trillion (£4,000,000,000,000) and

the top 1% accrued nearly a quarter of it and accumulated wealth 31 times faster than the remaining 99%. The rich are getting richer while others live in terrible poverty, having to use food banks and other charities to supply their basic needs and with nothing left over to go out and have fun. Surely this can't be right?

I don't know if any of the super-rich live here in Shillington but a quick look at houses around the village suggests that there is quite a variation in the wealth that different villagers have. We talk about how much people need to live on - a minimum or National Living wage to give it its official title - and there are probably some Shillington people here who earn just that. However, nobody seems to have thought about whether some people have too much wealth and whether it matters - until now. In Ingrid Robeyns' new book, *Limitarianism, the case against extreme wealth,* she does just that. Concluding that it does matter, what we need for the good of society, she argues, is for accumulated wealth to be taxable. Robeyns lives in the Netherlands where she suggests no one should be worth more than 10m euros with anything above that used instead for investing in the common good.

It wasn't always like this. Following success in the second world war, many resolved that there should be a lasting, fairer outcome for all and genuine progress was made to achieve it. To help rebuild the country, the rich continued to pay income tax at a top rate of 90%, twice that of today, and their money was put to good use. Those who could not afford to buy a house for example - the bombed out, the slum dwellers or those, like my Dad, who had joined the armed services as boys and returned as men, had married, were starting families and needed homes. When I was born in 1950, we were able to move into one of over 1.2 million council houses built after 1945 and pay a rent that really was affordable. Shillington gained many new council homes in Hanscombe End Rd, Bryants Close, Hillfoot Rd and Greenfields. Funds were also pumped into education and health with the NHS established in 1948 and pensions became available for all.

Other changes included setting up National Parks and safeguarding public rights of way. It was a

time when people could look forward to the world becoming a better place - a time of optimism. Sadly, Governments are no longer so productive. It's sad that for many people today, the prospects aren't good. We see schools and roads crumbling and long delays getting everything from justice to health care to trains and buses while the wait for decent rented housing is outrageously long compared with when my parents needed it.



Does it have to be like this? Perhaps not, especially if we paid more tax. The median income in the UK is about £34,000 per year - 50% of people earn more than this and 50% earn less. The top rate of tax is now 45% and that is only levied on earnings above £125,140. The government assumes that anyone can manage on £10.42 per hour - that's the National Living Wage, which equates to about £20,600 per year.

If that's the case, anyone paying any of their tax at 45% is earning over £100,000 more than they need to survive. Surely they could be taxed a lot more? Just think of how much millionaires could contribute to the Exchequer if they paid tax fairly instead of exploiting loopholes to avoid or evade it. Could this come about? It may not be as fanciful as it seems. Robeyns mentions many examples of millionaires who have given away much of what they had.

At the recent wealthfest in Davos, 250 millionaires and billionaires signed a letter to world leaders requesting that they should be taxed more heavily. However, taxation is usually regarded in a negative way. It's something that newspapers campaign against and people moan about. Many think they are hard done-by and shudder at the thought of paying more. In their book, *Uncomfortably Off*, academics Gerry Mitchell and Marcos González Hernando offer a reason why that is the case.



Many of the better off work with others or have clients who are substantially richer than they are. Instead of comparing their lives with those of the person on £20,600 or even £34,000, they compare themselves with people earning £100k or a million. They see that these people have more than they do - bigger

cars and homes, more bling, more of everything. They feel that they are the ones who are underpaid. It seems that the more they earn, the more jealousy and envy colour their outlook and their perception of doing well.

Maybe attitudes need to change? They could look at it more positively and be proud that they have the good fortune to earn so much and are expected to pay a lot of tax. After all, they would be funding more nurses and more teachers. They would be making more money available to help those who are less fortunate than themselves. After all, none of us know when illness, redundancy, divorce or accident might suddenly turn our own finances upside down and leave us destitute. High earners often tell themselves that they earn a lot because they've worked hard for it, but there are plenty of people who work hard and don't earn a lot and people who do well not because they worked hard, but because they were in the right place at the right time. A healthy tax bill should be a badge of honour, not a reason to cry into your beer.

There's something else worth considering. The richer you are, the more likely it is that your lifestyle is contributing to climate breakdown. The wealthy fly much more and generally consume more stuff which makes their carbon emissions higher than those of the average person. If they cut back, it would be good for everyone and good for the planet too.



Elections are coming up this year in the UK, the US and in many other countries. Voters here will have the chance to elect new MPs and indirectly, the next Prime Minister. Our Mid Bedfordshire constituency will be a very different shape compared with when we went to the polls at the by-election in October. Boundary

changes mean that Shefford, Arlesey and Stotfold will have left and joined the new Hitchin constituency. Alistair Strathern, whom we elected as our MP, has been very busy since replacing the discredited Nadine Dorries. He has settled in Shefford and decided that he wants to continue to live in his constituency and concluded that he has a better chance of returning to Westminster in the new Hitchin one. When we vote, we will have a choice of other candidates. I hope that there is someone we can vote for who will work as hard as Alistair, someone with vision, someone who wants a better future for everyone and not just for the wealthy. Someone who can offer hope.



Shillington and the nearby area have seen many changes over the years and another went by recently but was barely noticed. Henlow greyhound stadium closed its doors for the final time on 21 January. Greyhound racing had its origins long ago when owners pitted their dog against each other in open

countryside in the pursuit of live quarry, usually hares. It was known as coursing but concern about cruelty to the hares led to it being banned in most countries. However, the development of an artificial hare made it possible to race in more controlled conditions in a stadium and Henlow was among the first to open in 1927. Like the other tracks, it attracted mainly working class men who could attend the evening meetings after they'd finished work as well as servicemen from Henlow Camp. It quickly proved popular for the spectacle and betting opportunities and attendances reached their peak in the late 40s.



For much less than it would have cost to own and train a horse, you could have the thrill of winning a race with a greyhound and several Shillington people have owned dogs that raced there. However, television and other entertainment began to take fans away in the 1950s and the sport has suffered a slow decline ever since. There was a small revival after 2004 when

a new promoter took over. Occasionally, animal rights protesters would turn up, concerned about the welfare of the greyhounds. In recent years, as paying customers have dwindled, the sport has been televised and shown globally with gambling in far eastern countries helping to sustain it. At Henlow though, new housing developments have been springing up all around and it was inevitable that the owners would decide to sell up, just four years before its centenary would have been celebrated by its handful of loyal supporters.

School Governors needed at the

Shillington and Stondon Federation



We are currently seeking new School Governors and would be delighted if people in the Federation's local villages and wider communities would take up the posts.

What is a School Governor?

School Governors have a varied and important role, in helping our schools run effectively. They have 3 core functions:

- · Planning the strategic direction of the schools
- · Overseeing financial performance of the schools and ensuring money is well spent
- Holding the Headteacher and schools' leadership to account

The Governor role is strategic rather than operational. Governors don't get involved with the day to day running of the schools, instead they support and challenge the schools' leadership team to drive school improvement. They champion the work the schools do.

Our Governing Board

Our Board consists of 10 people at present, and we meet all together 5 times per year – usually in person on a weekday evening for up to two hours. We also have two main committees that Governors join either or both: a Resources and Planning Committee, which oversees how money is spent, and a Standards, Teaching and Learning Committee, which monitors pupil's educational outcomes.

Governors also:

- get to know the schools, including visiting the schools e.g. once a term as a Link Governor with a particular area of focus, during school hours and in agreement with the Headteacher, and gaining a good understanding of the schools' strengths and weaknesses
- attend induction training and regular relevant training and development events, much of which
 is online and can be completed at a time to suit Governors
- attend meetings (Full Governing Board meetings and relevant Committee meetings) and read all the papers before the meeting
- · act in the best interests of all the pupils of the schools
- behave in a professional manner, as set down in the Governing Board's code of conduct, including acting in strict confidence

Being a School Governor is a voluntary role involving commitment and responsibility, but offers you the chance to see first-hand the impact you can make in improving education for children in the Federation.

Do I need to have certain gualifications?

No special qualifications are needed and the most important thing is to have a keen interest in the schools and be prepared to play an active part in the Governing Board's work. We welcome applications from people from all backgrounds. You do not need to have a child at the school to apply.

SHILLINGTON CHILDMINDERS

Childminders provide safe, friendly home environments for children to play and have fun whilst gently learning through their play. We take children on outings to farms, play centres, splash parks, museums and libraries, as well as teach them life skills such as helping to do shopping, gardening and cooking.

We are individually registered to Ofsted, have public liability insurance, follow the Early Years Foundation Stage curriculum, undertake regular training including Safeguarding and First Aid and receive regular newsletters and bulletins from professional organisations.

We provide the children with opportunities to learn social skills and experience different play resources at baby/toddler groups and other settings. We are able to cover holidays and other absences for each other where possible.

Some of us are able to provide up to 15 hours of free childcare a week for eligible 2 year olds, as soon as care starts, in the same way that nurseries and pre-schools can. We are also able to provide the free sessions for all 3 and 4 year olds; at least 15 hours per week or up to 30 hours per week (for 38 weeks of the year) depending on parental eligibility and the childminder's policy. The free sessions normally start the term after the child's 3rd birthday. There may be additional charges to cover e.g. food and outings.

We each have differing childcare availability such as before and after school care, daytime childcare, overnight childcare, ad-hoc care or flexible care e.g. for shift workers.
